## **TERMS AND CONDITIONS:**

1. Tender shall be accepted only from Manufacturers/ authorized dealers and multinational companies dealing in import/export of milk coolers.

2. Conditional Tenders will be rejected.

3. No advance payments will be made.

4. A designated technical committee will determine the reliability and technical aspects of the milk cooler

5. milk cooler consignment should be delivered within 30 days of confirmation of the order.

6. Warranty should be minimum of more than 6 months of period .

**7. Alternative offers shall not be considered.** The bidders are advised not to quote different options for the same item but furnish the most competitive among the options available to the bidder.

8. If the bidder has different type of product they are advised to submit individual bid form for each product

9. This form must be completed without any alterations to its format, and **no substitutes shall be** accepted. All blank spaces shall be filled in with the information requested.

10. Bidders responsibility is supply relevant documents and evidence to evaluation

12. The Quotation shall comprise the following:

(a) Quotation Submission Form (annexed 1) and the Price Schedules; (annexed 2)

- Bidder shall be a legally registered company in Sri Lanka and has been in operation for the last five (05) years.  
Copy of Certification of Incorporation or Memorandum of articles or Partnership Deed.
- Copy of Tax registration certificate and VAT Registration
- Self-attested copies of purchase order and their respective project completion certificates issued by clients for similar goods/projects.
- Bidders and agents shall have experience as the authorized dealers/suppliers milk coolers offered in the bid for the last 3 years in supply,
- Alternative bids shall not be considered. Options are not allowed; the bids submitted with options shall be treated as non-responsive and shall be rejected.
- Authorized dealers must attach the authorization letter from the Mother company

- All the literature, web site link that support technical committee to evaluate.
- If need technical committee will request sample of your products and on that request you hve to submit samples

**Evaluation criteria**

The Technical committee strictly consider the given terms and conditions. those bidders who donot fullfill the rquirements will berejected. Other than given terms and conditions written coments and complains from the veterinary surgeons also will be considered .
